**FIRST QUARTERLY RESULTS ANNOUNCEMENT
FOR THE THREE MONTHS ENDED 31 MARCH 2022**

**CHARACTERISTICS OF THE GEM OF THE STOCK EXCHANGE OF HONG KONG LIMITED
(THE “STOCK EXCHANGE”)**

GEM has been positioned as a market designed to accommodate small and mid-sized companies to which a higher investment risk may be attached than other companies listed on the Stock Exchange. This announcement, for which the directors of China Geothermal Industry Development Group Limited (the “Company”) collectively and individually accept full responsibility, includes particulars given in compliance with the Rules Governing the Listing of Securities on the GEM (the “GEM Listing Rules”) of the Stock Exchange for the purpose of giving information with regard to the Company. The directors, having made all reasonable enquiries, confirm that to the best of their knowledge and belief the information contained in this announcement is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this announcement misleading.

HIGHLIGHTS

Revenue for the three months ended 31 March 2022 (the “Review Period”) amounted to approximately HK\$23,640,000.

Net loss after tax of the Group for the Review Period amounted to approximately HK\$14,996,000.

No dividend was declared for the Review Period.

FINANCIAL REVIEW

The following table provides a brief summary of the financial results of China Geothermal Industry Development Group Limited (the “Company”) and its subsidiaries (collectively the “Group”). For more detailed information, please refer to the unaudited consolidated financial statements for the Review Period and for the three months ended 31 March 2021.

During the Review Period, the Group's revenue amounted to approximately HK\$23,640,000 which was mainly contributed by shallow geothermal energy utilisation business as compared with that of approximately HK\$25,695,000 for the corresponding period last year. The revenue decreased by approximately HK\$2,055,000 as compared with that of corresponding period last year. The revenue for the Review Period decreased by approximately 8.0% as compared with the same period last year. The decrease was mainly due to the continuous and repeated epidemic situation and the implementation of restrictions on personnel travel management by the government, which resulted in the delay of project construction during the Review Period. At the same time, the number of projects under construction carried over from the previous year decreased compared with that of the same period last year as well as no revenue from sales of air conditioning/shallow geothermal energy heat pump products was recorded during the Review Period. The Group's gross profit margin decreased from 19.0% in last corresponding period to 13.5% in the current period.

Other income and gains increased from approximately HK\$2,121,000 in the corresponding period last year to approximately HK\$2,772,000 for the three months ended 31 March 2022.

Selling and distribution expenses amounted to approximately HK\$5,221,000 and HK\$5,076,000 for the three months ended 31 March 2022 and 2021 respectively. Besides, administrative expenses amounted to approximately HK\$12,427,000 and HK\$19,758,000 for the three months ended 31 March 2022 and 2021 respectively.

During the Review Period, administrative expenses significantly decreased by approximately 37.1% as compared with the same period last year. The decrease was mainly attributable to the strict implementation of various cost and expenses control measures by the Company. At the same time, the implementation of salary reduction measures for executive directors for this year in order to fulfil their commitment to lead the Company to jointly fight against the epidemic, maintain production and promote employment as well as the formulation of new remuneration plan for employees, resulting in a decrease in salary expenses during the Review Period.

Finance costs amounted to approximately HK\$133,000 for the three months ended 31 March 2022 as compared with approximately HK\$796,000 for the last corresponding period. The decrease of finance costs was due to the repayment of all bank loans.

For the three months ended 31 March 2022, the loss for the Review Period was approximately HK\$14,996,000 versus approximately HK\$23,359,000 for the corresponding period in last year. The loss during the Review Period reduced by approximately 35.8% as compared to the same period last year. The decrease in loss during the Review Period was mainly attributable to the substantial reduction in administrative expenses of the Company.

BUSINESS REVIEW AND OUTLOOK

During the Review Period, the revenue of the Company amounted to approximately HK\$23,640,000, mainly from the shallow geothermal energy utilization business, of which engineering construction accounted for approximately 46.9% of the revenue, operation and maintenance accounted for approximately 53.1% of the revenue. During the Review Period, the revenue decreased by approximately 8% as compared to that of the same period last year. The major objectives of the Group are to fight the pandemic, ensure safety and ensure employment. With difficulties in broadening source of income, we earnestly focus on internal management to reduce expenditure and expenses. Making every effort to ensure the sustainability and safety of the enterprise.

During the Review Period, in order to strengthen our management of funds, the Group adopted the principles of no advance, no borrowing, no arrears. While improving and strengthening corporate governance, it's required that contracts shall be executed strictly in accordance with laws and regulations. We also spared efforts in collecting debts, thereby increasing the Company's cash flow and ensuring normal capital flow for operations need.

While the pandemic situation remains volatile under the current environment, the Group has actively been collecting bidding information for ground source heat pump heating projects while adhering to the government's epidemic prevention and control measures. The Group expands the scope of information from point to area, and strives to develop the market of utilization of shallow geothermal energy as an alternative energy source for heating. At the same time, the projects carried over from the previous year would be constructed in a conditional manner. In terms of market expansion, the Company actively promotes coal-to-electricity transformation in rural areas such as Yan'an, Inner Mongolia, and Shandong by various business models, and strengthens the utilization of shallow geothermal energy and air source heat pumps in the industry. On the other hand, the Company conceives and adjusts a new model, aiming to implement energy transformation projects for public buildings in a certain area in a centralized package. The Company will use its best endeavors to enhance its business and market capabilities. In addition, adjustments were made to the remuneration and assessment mechanism of marketing personnel, proportion of performance-based wages are increased linking to job responsibilities, actual contributions and work performance to give more incentives, thereby improving the overall performance of the Company.

In the new era, the Group aim to strengthening the promotion of green development and building an ecological civilization. Shallow geothermal energy, as a kind of clean energy, has the characteristics of clean, low-carbon and wide distribution, and its development and utilization potential is huge.

On 30 January 2022, the National Energy Administration of the National Development and Reform Commission issued the “Opinions on Improving the System, Mechanism and Policy Measures for Energy Transformation to be Green and Low-Carbon ” [Fa Gai Neng Yuan [2022] No. 206], which has provided favorable policy guarantees for the promotion of the utilization of shallow geothermal energy as an alternative energy sources for heating.

Although the performance of the Group has slowed down in the past two years, the Company has repaid all loans so as to reducing financial costs. The Group will be adapting to the new form and seeking new development with light financial cost burden. As a system service provider of integrated heating and cooling in investment, construction and operation under the new form, the Group continues to improve various management, internal control and governance structures, improve the quality of personnel and work. The Company will actively seize opportunities through various means to adapt to changes in the market environment, and pursue the maximization of shareholders’ interests.

NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the three months ended 31 March 2022

1. GENERAL

China Geothermal Industry Development Group Limited (the “Company”) was incorporated in Cayman Islands as an exempted company with limited liability and its shares are listed on the GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The addresses of the registered office and principal place of business of the Company are P.O. Box 31119, Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman KY1-1205, Cayman Islands and 8/F, Chung Hing Commercial Building, 62-63 Connaught Road Central, Central, Hong Kong respectively.

During the period, the Group was involved in the following principal activities:

- Provision, installation and maintenance of shallow geothermal energy utilisation system
- Trading of air conditioning heat pump products
- Investment in properties for their potential rental income
- Trading of securities and other types of investments

2. BASIS OF PREPARATION

The condensed consolidated financial statements have been prepared in accordance with the applicable disclosure requirements of Chapter 18 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”) and with Hong Kong Financial Reporting Standards (“HKFRSs”), Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”). These financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

The accounting policies adopted in the preparation of the financial statements are consistent with those adopted in preparing the audited financial statements for the year ended 31 December 2021.

The Group has adopted new and amended standards and interpretations of HKFRSs which are mandatory for the accounting periods beginning on or after 1 January 2022 and relevant to its operations. The adoption of such new and amended standards and interpretations does not have material impact on the condensed consolidated first quarterly financial information and does not result in substantial changes to the Group’s accounting policies.

The Group has not applied the new HKFRSs that have been issued but are not yet effective but is in the process of assessing their impact on the results of operation and financial position of the Group.

The condensed consolidated accounts have not been audited by the Company’s auditor, but have been reviewed by the Company’s audit committee.

Basis of consolidation

The consolidated financial statements include the financial statements of the Group for the period ended 31 March 2022. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e. existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.
