Ms. Chan, aged 37, is an associate member of Hong Kong Institute of Certified Public Accountants and an associate member of the Hong Kong Chartered Governance Institute. She holds a bachelor’s degree of accounting from Edinburgh Napier University in United Kingdom in 2008. Ms. Chan has over 10 years of auditing, accounting, corporate governance and company secretarial experience.

The Board would like to express its gratitude to Ms. Wong for her contributions to the Company during the tenure of her service and welcome Ms. Chan on her new appointment.
