## GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES, RE-ELECTION OF DIRECTORS, AMENDMENT TO THE ARTICLES OF ASSOCIATION AND NOTICE OF ANNUAL GENERAL MEETING

#### INTRODUCTION

The purpose of this circular is to provide you with the relevant information regarding the granting of the General Mandate and the Repurchase Mandate, the re-election of Directors, amendments to the Articles of Association and to give you notice of AGM at which ordinary resolutions will be proposed to consider, and if thought fit, approve at the AGM, among other matters, the granting of the General Mandate and the Repurchase Mandate and the re-election of Directors and special resolution will be proposed to amend the existing Articles of Association of the Company.

#### GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

At the annual general meeting of the Company held on 3 February 2006, ordinary resolutions were passed to grant to the Directors general unconditional mandates (i) to repurchase Shares of the Company

on GEM or on any other exchange on which the Shares have been or may be listed and recognised for this purpose by the SFC and the Stock Exchange under the Repurchases Code, which does not exceed 10 per cent. of the aggregate nominal value of the issued share capital of the Company on the date of passing the relevant resolution; and (ii) to allot, issue and otherwise deal with Shares of the Company up to the limit of 20 per cent. of the aggregate nominal value of the issued share capital of the Company on the date of passing such resolution. No Shares have been repurchased pursuant to the repurchase mandate granted.

These general mandates will lapse at the conclusion of the forthcoming Annual General Meeting of the Company which will be held at Mont Blanc Room, Pacific Place Conference Centre, Level 5, One Pacific Place, 88 Queensway, Hong Kong at 10:30 a.m. on 7 February 2007. At the AGM, ordinary resolutions will be proposed:

As at the Latest Practicable Date, the authorised share capital of the Company was US\$20,000,000 divided into 2,000,000,000 Shares, of which 1,628,160,470 Shares were in issue. There were 33,400,000 outstanding options under the Company's share option schemes, to subscribe up to 33,400,000 Shares.

On the basis of 1,628,160,470 existing Shares in issue as at the Latest Practicable Date, the Directors would be authorised to repurchase up to 162,816,047 Shares which represent 10 per cent. of the 1,628,160,470 existing Shares in issue as at the Latest Practicable Date.

In the event that all the options are exercised in full on or before 4:00 p.m. on Monday, 5 February 2007 from the holders of options granted under the Company's share option schemes, the number of Shares in issue will be increased to 1,661,560,470. On the basis of such figure (and assuming no Shares are purchased or further issued) the Directors would be authorised to repurchase up to 166,156,047 Shares which represent 10 per cent. of such 1,661,560,470 Shares.

The Repurchase Mandate allows the Company to make repurchase only during the period from the date of the passing of the relevant resolution until the earliest of the conclusion of next annual general meeting of the Company, the date by which the next annual general meeting of the Company is required

by the articles of association of the Company, or any applicable law of the Cayman Islands to be held and the date upon which the Repurchase Mandate is revoked or varied by an ordinary resolution of shareholders of the Company in general meeting.

In accordance with the GEM Listing Rules, the Company is required to send to the Shareholders an explanatory statement containing all information reasonably necessary to enable them to make an informed decision on whether to vote for or against the ordinary resolution to renew the grant to the Directors of the Repurchase Mandate. Such explanatory statement is set out in the Appendix I to this circular.

#### **RE-ELECTION OF DIRECTORS**

In accordance with Articles 86 and 87 of the Articles of Association of the Company, each of Mr. Xu Zhi Feng, Mr. Yukihiko Izutsu and Mr. Liu Yang would retire by rotation at the forthcoming Annual General Meeting. Each of them, being eligible, would offer himself for re-election. Details of Mr. Xu Zhi Feng, Mr. Yukihiko Izutsu and Mr. Liu Yang are set out in the Appendix II to this circular.

#### AMENDMENTS TO THE ARTICLES OF ASSOCIATION

The latest amendments to the GEM Listing Rules relating to Code on Corporate Governance Practices and Corporate Governance Report came into effect on 1 January 2005. The principal purpose of the special resolution as set out in the Notice of Annual General Meeting is to amend the Articles of Association to, amongst others, comply with the requirements of the amended GEM Listing Rules.

The proposed amendments, if duly passed, will have the following effects: (1) a poll may be demanded by such persons and voting figures will be disclosed as required by the GEM Listing Rules; (2) one-third (nearest to but not lower than one-third) of all the directors (including the chairman and managing director) must retire at each annual general meeting of the Company; (3) any director appointed by the board of directors may only hold office until the next following general meeting of the Company in the case of filling a casual vacancy and until the next following annual general meeting of the Company in the case of an addition to the Board; (4) directors can be removed by ordinary resolutions; and (5) a copy of either the directors report, accompanied by the balance sheet (including every document required by law to be annexed thereto) and profit and loss account or income and expenditure account, or the summary financial report in the form and containing the information required by applicable laws and regulations shall be sent to Shareholders at least 21 days before the annual general meeting of the Company.

To align the Articles of Association with the amendments to, amongst others, the GEM Listing Rules, the Board proposes that the Articles of Association be amended in the manner as set out in the special resolution. The full text of the proposed amendments to the Articles of Association is set out in the Notice of Annual General Meeting.

A special resolution to amend the Articles of Association, which requires not less than 75 percent of the votes cast by the Shareholders attending and entitled to vote at the AGM, will be put forth as special business to be considered and approved by the Shareholders at the AGM.

#### ANNUAL GENERAL MEETING

A notice convening the AGM is set out on pages 14 to 18 of this circular, ordinary resolutions will be proposed to approve the General Mandate, the Repurchase Mandate and to re-elect Directors of the Company.

A proxy form for use at the AGM is enclosed with this circular. Whether or not you intend to attend the AGM in person, you are requested to complete the proxy form in accordance with the instructions printed thereon and return the same to the Company's share registrar, Computershare Hong Kong Investor Services Limited at 46th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding of the AGM or any adjournment thereof. Completion and return of the proxy form will not preclude you from attending and voting in person at the AGM or any adjournment thereof should you so wish.

Pursuant to Article 66 of the Articles of Association of the Company, at any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands, unless a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:

- (a) by the chairman of such meeting; or
- (b) by at least three Shareholders present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy for the time being entitled to vote at the meeting; or
- (c) by a Shareholder or Shareholders present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy and representing not less than one-tenth of the total voting rights of all Shareholders having the right to vote at the meeting; or
- (d) by a Shareholder or Shareholders present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy and holding Shares conferring a right to vote at the meeting being Shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all Shares conferring that right.

Unless a poll is so demanded and the demand is not withdrawn, a declaration by the chairman that a resolution has, on a show of hands, been carried, or carried unanimously, or by a particular majority, or not carried by a particular majority, or lost, and an entry to that effect made in the minute book of the Company, shall be conclusive evidence of the fact, without proof of the number or proportion of the votes recorded for or against that resolution.

#### RECOMMENDATION

The Directors believe that an exercise of the General Mandate may enable the Company to take advantage of market conditions to raise additional capital for the Company and the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share. The Directors consider that the granting of the Repurchase Mandate and the General Mandate, the re-election of the Directors and amendments to the Articles of Association to be proposed at the AGM are in the best interest of the Company and the Shareholders. Accordingly, the Directors recommend that all Shareholders should vote in favour of the relevant resolutions to be proposed at the AGM.

## **APPENDIX I**

## **EXPLANATORY STATEMENT**

#### **RESPONSIBILITY STATEMENT**

This document, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the GEM Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquires, confirm that, to the best of their knowledge and belief:

- 1. the information contained in this document is accurate and complete in all material respects and not misleading;
- 2. there are no other matters the omission of which would make any statement in this document misleading; and
- 3. all opinions expressed in this document have been arrived at after due and careful consideration and are founded on bases and assumptions that are fair and reasonable.

The following is the explanatory statement required to be sent to the Shareholders under the GEM Listing Rules in connection with the proposed general mandate for repurchases of Shares to be passed by the Shareholders by an ordinary resolution at the Annual General Meeting.

#### (1) Reasons for Repurchases

The Directors believe that it is in the best interest of the Company and its Shareholders for the Directors to have a general authority from Shareholders to enable the Company to repurchase Shares in the market. Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and its Shareholders. Such repurchases may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net value of the Company and its assets and/or its earnings per Share.

#### (2) Funding of Repurchases

The Directors wish to state that repurchases pursuant to the Repurchase Mandate would be financed entirely from the Company's available cash flow or working capital facilities and any repurchases will only be funded out of funds of the Company legally available for the purposes in accordance with its memorandum of association and articles of association and the laws of the Cayman Islands.

The Company may not repurchase its own Shares on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

#### (3) Impact of Repurchases

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in its latest published audited accounts for the year ended 30 September 2006) in the event that the proposed repurchases were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

#### (4) Exercise of the Repurchase Mandate

As at the Latest Practicable Date, the authorised share capital of the Company was US\$20,000,000 divided into 2,000,000 Shares, of which 1,628,160,470 Shares were in issue. There were 33,400,000 outstanding options under the Company's share option schemes, to subscribe up to 33,400,000 Shares.

On the basis of 1,628,160,470 existing Shares in issue as at the Latest Practicable Date, the Directors would be authorised to repurchase up to 162,816,047 Shares which represent 10 per cent. of the 1,628,160,470 existing Shares in issue as at the Latest Practicable Date.

#### (5) Disclosure of Interest

Rule 13.11(2) of the GEM Listing Rules prohibit a company from knowingly repurchasing its shares on GEM from a connected person (as defined in the GEM Listing Rules) and a connected person is prohibited from knowingly selling his/her/its shares to the company on GEM.

None of the Directors and, to the best of their knowledge, having made all reasonable enquiries, none of their respective associates, have any present intention, if the Repurchase Mandate is approved by the Shareholders of the Company, to sell any Shares to the Company or its subsidiaries.

As at the Latest Practicable Date, no connected persons (as defined in the GEM Listing Rules) of the Company have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Company is authorised to make repurchases of the Shares.

#### (6) Directors' Undertaking

The Directors have undertaken to the Stock Exchange that they will exercise the power of the Company to make purchases pursuant to the proposed resolution, if granted, in accordance with the GEM Listing Rules, the applicable laws of the Cayman Islands and the regulations set out in the memorandum and articles of association of the Company.

#### (7) Share Repurchase made by the Company

No repurchases of Shares have been made by the Company during the six months (whether on GEM or otherwise) preceding the Latest Practicable Date.

#### (8) Takeovers Code Consequences

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase of the Shareholder's interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Multico Holdings Limited ("Multico") held directly 356,540,350 Shares, representing approximately 21.89% of the issued share capital of the Company and Transpac Capital Pte Ltd. ("Transpac") held indirectly through Multico and Huiya South China Investments Limited, which are the wholly owned subsidiaries of Transpac, 356,580,350 Shares, representing 21.90% of the issued share capital of the Company. In the event that the Directors exercised in full the power to repurchase Shares of the Company in accordance with the terms of the Repurchase Mandate, Multico's and Transpac's proportionate interests in the voting rights of the Company would respectively be increased to approximately 24.32% and 24.33% and Multico and Transpac would not be obliged to make a mandatory offer under Rule 26 of the Takeovers Code in this respect.

Save as aforesaid, the Directors are not aware of any consequences which would arise under the Takeovers Code as a consequence of any repurchase pursuant to the Repurchase Mandate. Moreover the Directors have no intentions to exercise the Repurchase Mandate to such an extent that would result in the level of shareholdings in the Company held by the public below the minimum public float as required under the GEM Listing Rules.

## APPENDIX II DETAILS OF DIRECTORS PROPOSED TO BE RE-ELECTED

The following are the particulars of the directors proposed to be re-elected at the AGM:

**Mr. Xu Zhi Feng** ("Mr. Xu"), aged 43, was appointed as executive Director of the Company on 7 July 2006 and is the General Manager of Product Department of the Group. Mr. Xu holds a Bachelor's degree in Mathematics from Jinan University (暨南大學). Prior to joining the Group in 2002, he had worked for The Industrial and Commercial Bank of China and was responsible for credit and financing work during 1985-1990. He also has over 10 years experience in telecommunications industry.

There is a service contract entered into between Mr. Xu and the Group for an initial term of two years from 7 July 2006. Mr. Xu is subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Company's Articles of Association. The director's emolument of Mr. Xu is HK\$500,000 per annum which is fixed with reference to market conditions and his duties and responsibilities with the Group. Save as disclosed above, Mr. Xu has not previously held any positions with the Company or its subsidiaries and does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company.

As at the Latest Practicable Date, Mr. Xu held 4,376,000 shares of the Company representing approximately 0.27% of the issued share capital of the Company. Mr. Xu was also granted options to subscribe for 1,000,000 Shares which are exercisable during the period from 5 June 2003 to 21 December 2011 at an exercise price of HK\$0.078 per Share. Save as aforesaid, as at the Latest Practicable Date, he does not have any interests in the Shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as disclosed above, there are no other information for Mr. Xu which are required to be disclosed pursuant to Rule 17.50(2) of the GEM Listing Rules and no other matters that need to be brought to the attention of the shareholders of the Company.

**Mr. Yukihiko Izutsu** ("Mr. Izutsu"), aged 61, was appointed as non-executive Director of the Company on 1 June 2006. Mr. Izutsu graduated from Kyoto Sangyo University in 1968. Save as disclosed above, Mr. Izutsu has not previously held any positions with the Company or its subsidiaries and does not have any relationship with any director, senior management or substantial or controlling shareholders of the Company. As at the Latest Practicable Date, Mr. Izutsu has no interests in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as disclosed above, there are no other information for Mr. Izutsu which are required to be disclosed pursuant to Rule 17.50(2) of the GEM Listing Rules and no other matters that need to be brought to the attention of the shareholders of the Company.

## APPENDIX II DETAILS OF DIRECTORS PROPOSED TO BE RE-ELECTED

**Mr. Liu Yang** ("Mr. Liu"), aged 34, was appointed as the independent non-executive Director and member of the audit committee of the Company on 28 January 2005. He is a senior counsel of Beijing Seafront Law Office.
